TASK ORDER 002 / SWAT UPDATE

SWAT (Shock, Whole Blood, and Assessment of TBI) was an observational study conducted at seven U.S. trauma centers with 1,051 patients at risk of hemorrhagic shock (70% of whom received massive transfusion). The SWAT dataset can be used for secondary analyses and was made available to all LITES investigators in February 2025. CriSP-TBI

The primary manuscript for CriSP-TBI was published ahead of print in January in the Annals of Surgery. Read it here: DOI - 10.1097/SLA.00000000006640.

The study found that in brain injured patients requiring platelet transfusion, early cold stored platelet transfusion is feasible, and did not result in improved 6-month Glasgow Coma Scale-Extended scores. Early cold stored platelet transfusion was associated with a lower rate of neurosurgical operative intervention without an increase in adverse events. The storage age of the cold stored platelet product was not associated with outcome differences.

As of 4/1/25, we are at 1729 enrollments which means we only need 261 enrollments to complete enrollment!


Monitoring Committee/All-Site calls continue the 2nd Friday of each month at 10am (ET). The next calls will be on April 11th, May 9th, and June 13th. This once-a-month call provides all the details of how the study is progressing and distributes the Study Monitoring Committee tables so that all sites can follow our progress.

The last services to step over to SGA-first arm have done so and now all 24 EMS services will complete the study in the SGA-first arm.

The most recent DSMB meeting was held on 4/4/2025. Once we receive the communication from that meeting, we will forward it to all sites to keep in their regulatory binders.

As a reminder, all consent uploads are due on 4/30/2025. Also, continue to bill LITES monthly for percent effort and any data payment reports that you receive each month. Any subject with complete data entry and without edits on the last day of the month is eligible for payout at the beginning of next corresponding month.

Please continue to encourage your EMS service(s) to stay engaged. As we approach the summer months, we will start to develop a communication plan to end enrollments. More details to follow as we get closer to our 2009 needed enrollments. Stay tuned!


As of 4/1/25, we are at 65 of our 994 enrollments needed for the PAIN (<u>P</u>rehospital <u>A</u>nalgesia <u>IN</u>tervention) study.

Nine sites are currently enrolling: AGH, UPMC, Cooper University Hospital, Medical College of Wisconsin (Milwaukee), University of California San Diego, University of Cincinnati, University of Utah, Donald Guthrie Foundation, and Atrium Health.

Two sites anticipate starting enrollments within quarter 2 of 2025: University of California San Francisco and the University of Vermont Medical Center. We are also looking to onboard two additional sites, one in Texas and one in Utah. LITES is currently working with those sites to begin contracts and IRB reliance.

Pine Pharmaceuticals provided Spring Study Drug to enrolling sites which will require replacement on May 14, 2025. Please remember to update the kit status in MATRIX ASAP for those kits being destroyed/wasted when a new batch of drug is delivered.

Quarterly consent uploads and data payout lock occurred on February 28th for all enrollments in November, December, and January. Those consent reports were distributed March 31st. Please be sure to have signed reports returned by April 15th. Also, any queries will need answered by April 30th. The next Quarterly consent uploads and data payout lock will occur on May 31st for all subjects who were are enrolled in February, March, and April.

TASK ORDER 007 / TOWAR UPDATE

Since last quarter, the University of Manitoba Health Sciences Centre commenced enrollment and enrolled their first patient on February 26th! Enrollment study wide has surpassed 75% and we're in the home stretch. Based on current projections, enrollment is estimated to be complete by late spring or early summer of this year. Sites should begin local discussions regarding their wind down plan with their EMS services and blood suppliers in preparation for study closeout. A comprehensive plan from the Coordinating Center detailing study-wide closing procedures will be forthcoming.

TASK ORDER 008 / DEEP UPDATE

<u>D</u>SUVIA <u>Early Evaluation of Pain (DEEP) was an openlabel, prospective, randomized, interventional trial comparing standard pain medication to DSUVIA (sublingual sufentanil) for adult trauma patients with moderate to severe pain in the emergency department. The primary manuscript was published in Anesthesia and Analgesia in February 2025, "A Randomized Controlled Trial of Sublingual Sufentanil in Early Management of Pain in Trauma."</u>

TASK ORDER 010 / CAVALIER UPDATE

CAlcium and VAsopressin following Injury Early Resuscitation trial (CAVALIER), or Task Order 10, is a double blind, randomized multicenter trial designed to determine if prehospital calcium, early in-hospital vasopressin, or a combination improves outcomes in injured patients at risk of hemorrhagic shock.

Allegheny General Hospital enrolled the first prehospital phase CAVALIER subjects this quarter! Congratulations to AGH and collaborating EMS partners for a strong start. AGH has enrolled 6 in the prehospital phase and the Pittsburgh site has had 34 in-hospital phase enrollments as of April 1, 2025.
